British passport holders require a visa for India. Your passport must have six months validity beyond your return date and have two blank pages to be valid for travel.

ABBREVIATED BOOKING CONDITIONS

1. YOUR CONTRACT

The contract is between Textile Travels Ltd, Registered at Companies House, Cardiff on May 6th 2020, Registered No.12588127, and the client, who is any person travelling or intending to travel independently on a tour operated by Textile Travels Ltd. The contract, including all matters arising from it, is subject to English law and the exclusive jurisdiction of the English Courts.

2. BOOKING PROCEDURE

Prior to booking, please read the Textile Travel tour details and related information, and these booking conditions. If you have any questions please contact us for clarification. Please keep a copy of these booking conditions for yourself. To make a booking

you must be over 18 and have discussed and agreed your tour plan, and its cost with Sally on the phone or by email:

When you are happy with the arrangements, please print off and complete the downloaded Booking Form and send it to us by post to Sally Mason, Textile Travels Ltd, 27 Westmead Road, Bristol, BS5 8NY. Alternatively, print, complete, sign and scan the form and Email to sally@textiletravels.co.uk.

All necessary details including full name as per passport; date of birth; nationality; passport number; passport issue and expiry date and any pre-existing medical conditions you have which may affect your ability to complete your travel arrangements are required.

Whether you book alone or as a group, we will only deal with the lead name in all subsequent correspondence, including changes, amendments and cancellations. The lead name is responsible for ensuring the accuracy of the personal details or any other information supplied in respect of yourself and any other person travelling on the booking and for passing on any information regarding the booking or any changes made in relation thereto, to all persons travelling on such booking, including but not limited to information on schedule changes or copies of booking confirmations.

A deposit of £900.00 is required at booking. This is refundable up to 120 days before the tour start date.

See Cancellations By You below for full details of our cancellation policy. For bookings within the 8 weeks, (56 days) period before the tour start date, full payment will be required. The Booking Form contains bank transfer details of our trust account with Protected Trust Services for payment of the deposit and balancing payment.

We will treat each signed booking form returned as an offer by you to purchase a Textile Travels tour in accordance with these terms and conditions. A contract will only be in place between us and all persons named on the booking form once your deposit has cleared and we have issued a confirmation of this. The date on the confirmation will be the date the contract is made.

We will invoice you for the remainder of the cost of your Textile Travels tour, which you must pay no later than 8 weeks, (56 days) before departure. If the balance is not paid on time, we reserve the right to cancel your holiday and apply the cancellation charges outlined below. It is advisable for you to take out travel insurance at the time of booking to cover possible cancellation.

3. CANCELLATION BY YOU

Should you wish to cancel your holiday, you must notify us as soon as possible.

If written notification of cancellation is received before the start of the tour date the following cancellation charges will be applied:

- Up to 120 days before tour start date: full refund of deposit.
- 120 to 56 days before tour start date: deposit is non refundable, (Should minimum group numbers not be achieved by 56 days before the travel date, then a full refund of deposit will be issued should WE have to cancel the tour)
- 55 to 30 days before tour start date: 50% of balancing payment is refundable.
- Less than 30 days before tour start date: full holiday cost is 100% non-refundable

A cancellation will only be effective from when we receive a written request. The above cancellation fees are in addition to any fees which may be levied by accommodation providers, travel agents or third-party trip and transport operator fees. You are strongly advised to take out insurance that includes cancellation cover at the time of booking. If you leave your trip for any reason after commencement, we are not obliged to make any refunds for unused services.

CANCELLATION BY US

We reserve the right to cancel the tour up to 56 days prior to the tour start date, with notice in writing to the customer. We will not cancel less than 56 days before your departure date, except for force majeure, unavoidable and extraordinary circumstances, failure by you to pay the deposit and/or final balance; Because the minimum number required for the package to go ahead hasn't been reached or because of a perceived inability to deliver the tour safely. The minimum number required will be provided to you in the Holiday Details.

If we cancel your trip, you may be able to transfer amounts paid to a different departure date or receive a full refund in the case of minimum group numbers not being achieved. In circumstances where the cancellation is due to external events outside our reasonable control refunds will be less any unrecoverable costs.

We are not responsible for any incidental expenses that you may incur as a result of your booking being cancelled.

GROUP SIZE

Unless otherwise stated our textile tours are based on a maximum of 8 or 10 and a minimum of 6 or 8 depending on tour. Our prices vary depending on group size. If we have 8 guests booking a tour then the price will be slightly higher than if we have 10 guests booking. The balancing payment, including any discounts, due 56 days before travel, will be adjusted to reflect the final group size.

In the event that there are less than the minimum number of travellers for the tour you have booked, you will be advised no less than 60 days before the tour start date. At which time the tour will be cancelled and options for transference of your holiday or a full refund offered to you.
